Located in Farmington Hills, Michigan, Woodbrooke Hills Swim & Tennis Club (WHSTC) was established in 1962 as a private summer swim and tennis club with competitive swim and tennis teams. Our 6 lane lap pool with diving well, and four tennis courts renovated in 2012, provide a positive community atmosphere and friendly membership in a beautiful environment. Our pirate ship play structure was added in 2014, and our new pavilion was completed in 2015, ready for you to rent for any special event at the pool! Stay tuned for exciting new updates in 2017, including the men's and women's locker rooms! Other amenities include funbrella dining area, snack bar, gas grills, beach volleyball court, basketball court, and kiddie pool! Summer fun for the whole family from Memorial Weekend to Labor Day! To gain membership, please complete the application which is page 2 of this document. Once the application is approved by The Board, you will be contacted to complete the process. It won't take long!

All new members will purchase a bond, as WHSTC is member-owned. The current bond value is \$700, and is a one-time expense. There is a one-time administrative fee of \$100, and annual dues are currently \$550. Dues are paid annually between January and April 1, and The Board may establish early discounts or late fees each year. We have an online membership management system which will allow you to pay your annual dues on time and online via credit card (fees apply). The online system also allows you to edit your family profile, register for a variety of classes and events, rent the pavilion, and even add an account balance for the purchase of guest passes and snack bar items.

Please know that the ownership of a Woodbrooke Hills bond carries with it the responsibility of paying annual dues, whether you choose to use the club or not. If dues are not paid, ownership of the bond reverts back to WHSTC. Please consult our website and read the full bylaws before submitting your membership application.

If you wish to sell your bond at some point, the membership chair maintains a list of bonds available for sale. You may submit a membership withdrawal request to place your name on the sell list. The bonds are sold in chronological order from that list. If you find a private buyer, you may sell your bond that way as well. The club does not buy back bonds. We recommend reading the *Bond Sale Information* document found on our website for a full and detailed explanation about how to sell your bond, and the appropriate steps that need to be taken when that time comes.
